Continuation of Determining Exceptions to the World Cultures Requirement Discussion

The committee continued the discussion around the rubric and the history of the world cultures 8 week requirement. The committee discussed the importance of noting that students are not given a waiver of the requirement but rather that they could meet the World Cultures requirement through an alternate route. The committee discussed the following options: 1. Leave the World Cultures requirement alone and make decisions on individual petitions as needed; 2. Have more rigid guidelines; or 3. Offer more flexibility but develop a more clearly defined list of acceptable experiences to meet the World Cultures requirement. A consensus was reached on certain aspects of the rubric. The rubric will be revised and the committee will continue the discussion.
