NH LEGISLATURE FACES TOUGH YEAR, DIFFICULT ISSUES

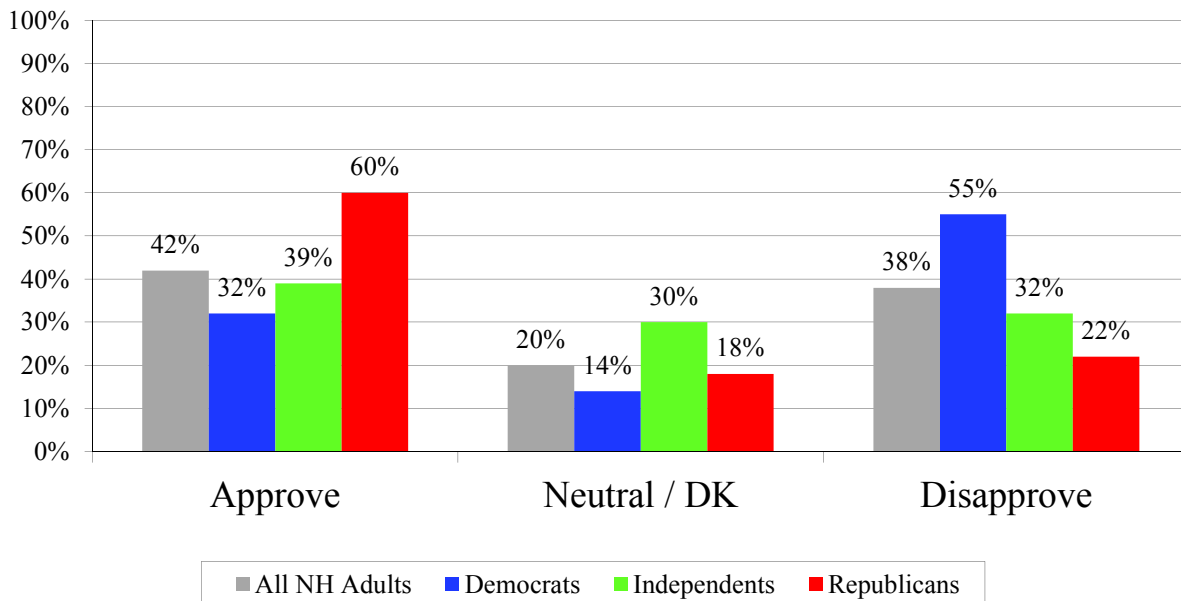
DURHAM, NH – The New Hampshire Legislature receives mixed reviews of how it has done its job. Legislative leaders Bill O’Brien and Peter Bragdon are mostly unknown in the state. Among controversial issues facing the Legislature, there is strong support for a voter ID law, little support for repealing gay marriage, and attitudes are divided on a constitutional amendment prohibiting an income tax, and for the Northern Pass project.

These findings are based on the latest **WMUR Granite State Poll**,* conducted by the University of New Hampshire Survey Center. Five hundred twenty-seven (527) randomly selected New Hampshire adults were interviewed by landline and cellular telephone between January 25 and February 2, 2012. The margin of sampling error for the survey is +/- 4.3 percent.

Approval of NH Legislature

Republicans gained large majorities in the New Hampshire House of Representatives and Senate after the 2010 election and after dealing with difficult budget issues in 2011, have turned to even more controversial issues in 2012. The state is split in how good of a job the Legislature is doing - 42% approve, 38% disapprove, and 20% are neutral or don't know enough to say. There is a significant partisan gap with 60% of Republicans approving of the job the legislature has done while only 32% of Democrats approve. Independents are split with 39% approving and 32% disapproving.

Approval Rating – NH Legislature

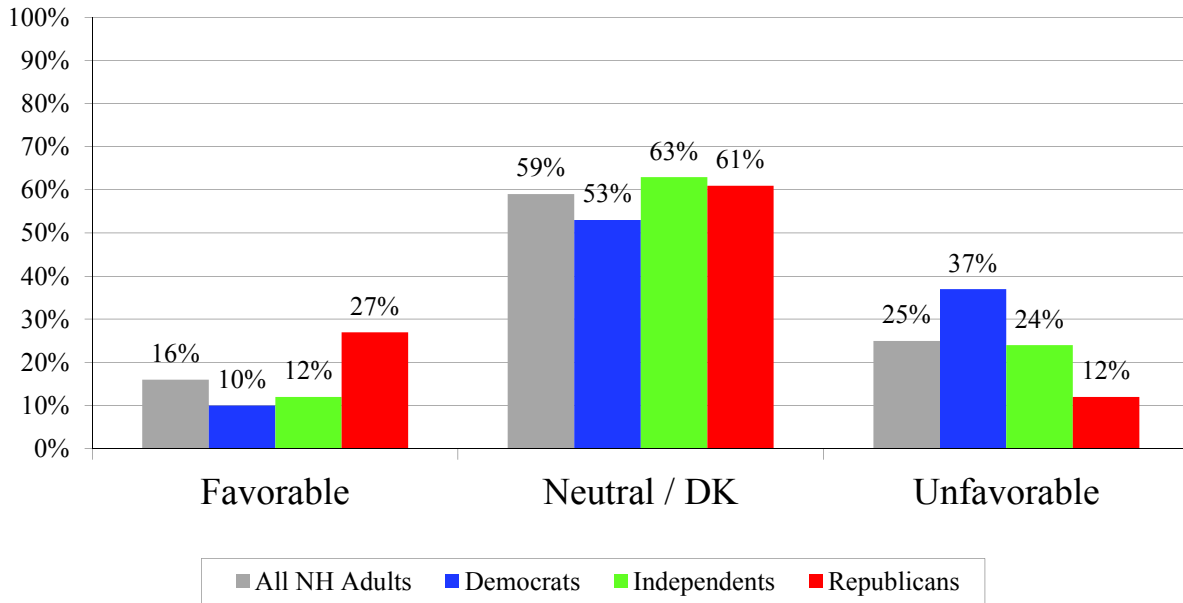

Favorability Ratings of Legislative Leaders

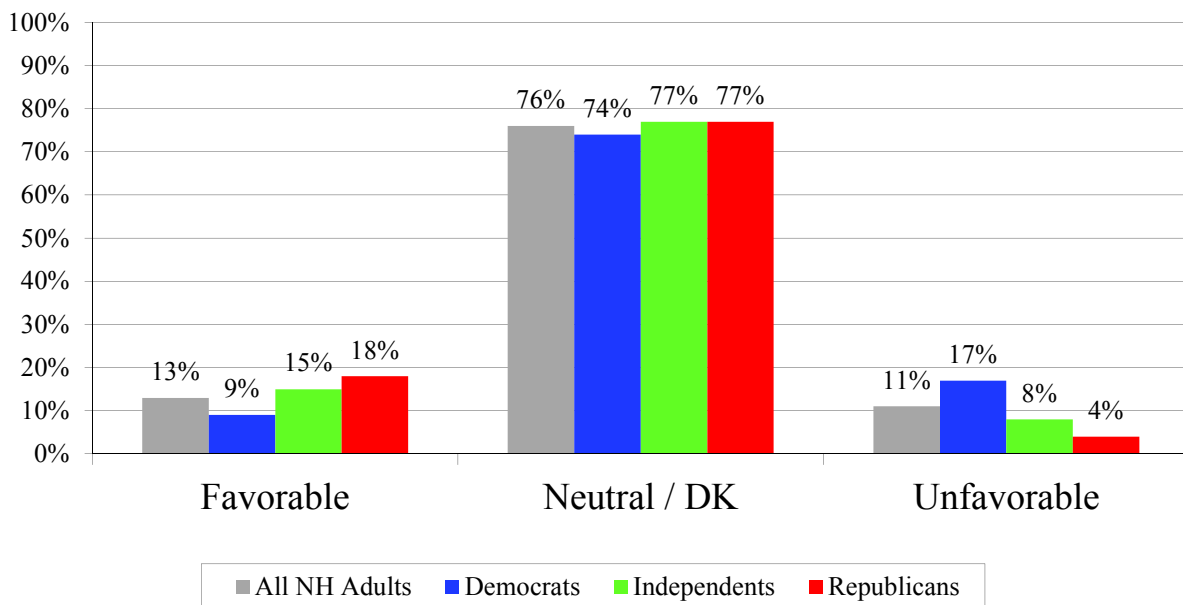
The leaders of the two Chambers of the New Hampshire legislature are largely unknown to New Hampshire adults, and perceptions of them are based strongly on partisanship. Only 16% of New Hampshire adults have a favorable opinion of House Speaker Bill O'Brien, 25% have an unfavorable opinion of him, 9% are neutral and 50% don't know enough about him to say. O'Brien's net favorability rating is -9%; -27% among Democrats, -12% among Independents, and +15% among Republicans.

Favorability Rating – House Speaker Bill O'Brien



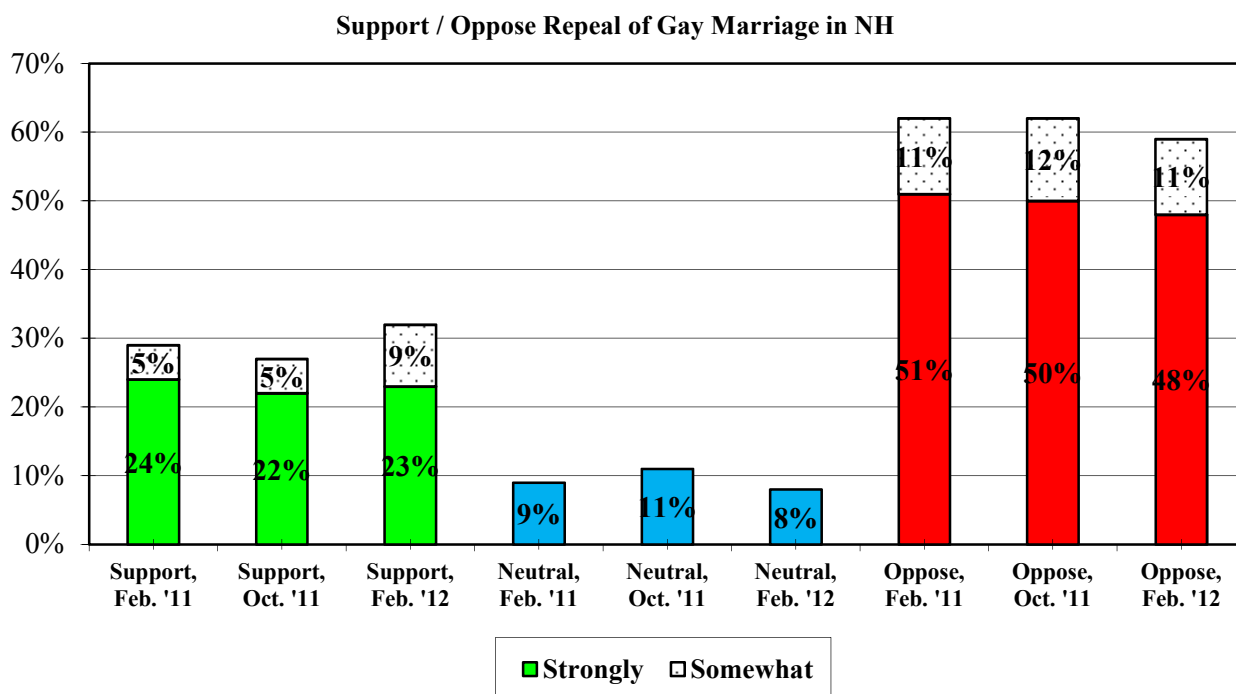
Senate President Peter Bragdon is even less well known, but less polarizing than Speaker O'Brien. Only 13% of New Hampshire adults have a favorable opinion of Bragdon, 11% have an unfavorable opinion of him, 10% are neutral, and 66% don't know enough about him to say. Bragdon's net favorability rating is +2%; -8% among Democrats, +7% among Independents, and +14% among Republicans.

Gay Marriage

Perhaps the most controversial issue facing the legislature is the proposed repeal of New Hampshire's 2009 law that legalized same-sex, or gay marriage. Opposition to a bill that would repeal gay marriage in New Hampshire remains strong – only 32% of New Hampshire adults support the repeal of the 2009 law that legalized gay marriage in New Hampshire (23% strongly support and 9% support somewhat), 48% strongly oppose repeal, 11% somewhat oppose repeal, and 8% are neutral or don't know. These figures have remained unchanged over the past year. Republicans are much more likely to favor repeal (58%) while Democrats (85%) and Independents (47%) oppose repeal.

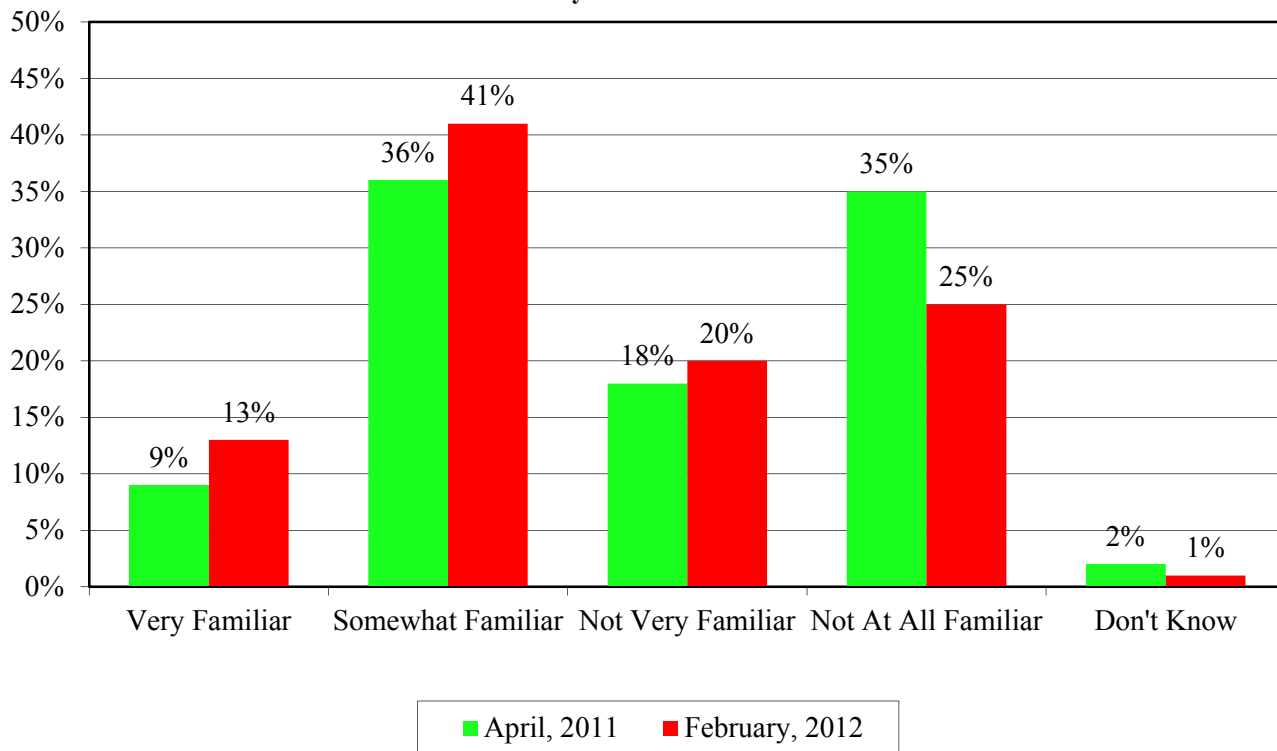


Opposition to repealing gay marriage in New Hampshire remains much stronger than support. When opponents of repeal are asked if they would be upset if it were gay marriage were repealed, almost half (46%) say they would be very upset, 28% would be somewhat upset, 9% would be not too upset, 14% would not be upset at all, and 2% are unsure. By comparison, when proponents of repeal are asked how upset they would be if gay marriage were not repealed, only 23% said they would be very upset, 38% would be somewhat upset, 20% would be not too upset, 16% would not be upset at all, and 3% are unsure.

Northern Pass

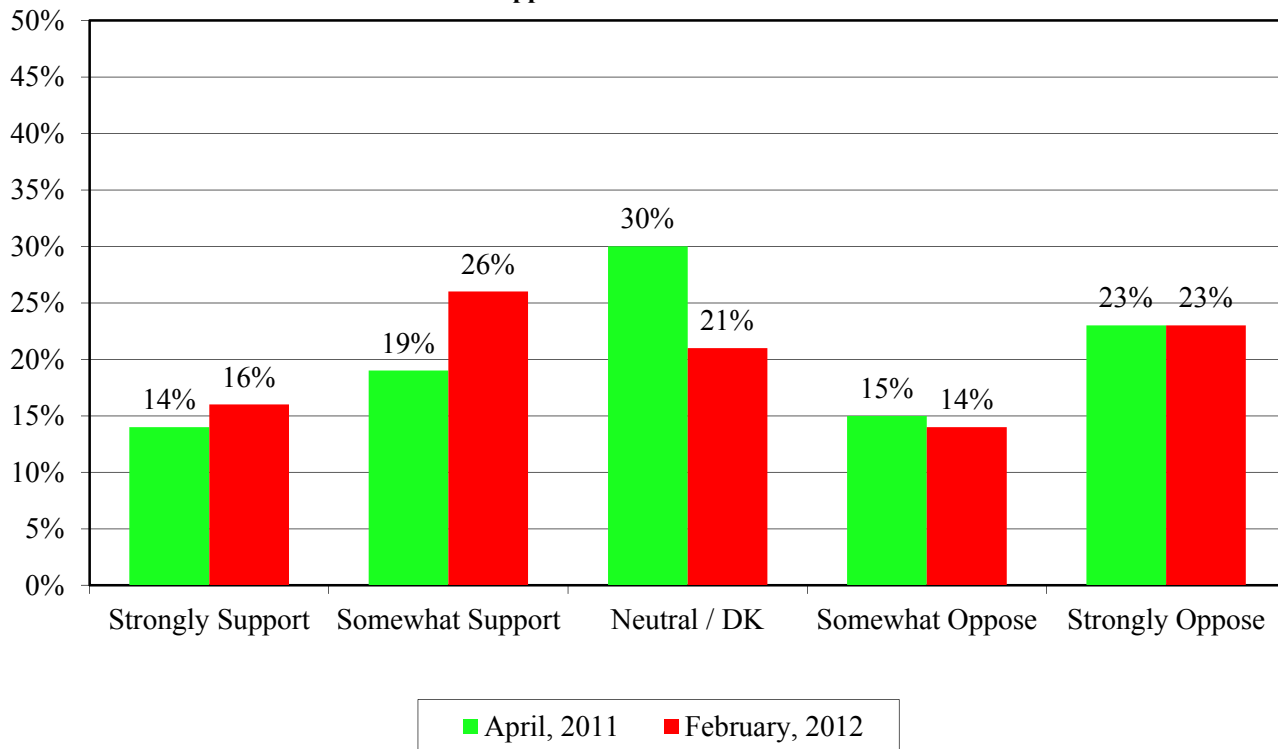
Another controversial issue facing the state is the proposed "Northern Pass" project which would bring hydro-power electricity from Canada through New Hampshire on high tension wires, but many North Country residents have expressed strong opposition to the project. Over the past nine months, there has been an increase in awareness of the project, yet it is still somewhat low. Only 13% of New Hampshire adults say they are very familiar with Northern Pass, 41% are somewhat familiar, 20% are not very familiar, and 25% are not familiar at all.

Familiarity with Northern Pass



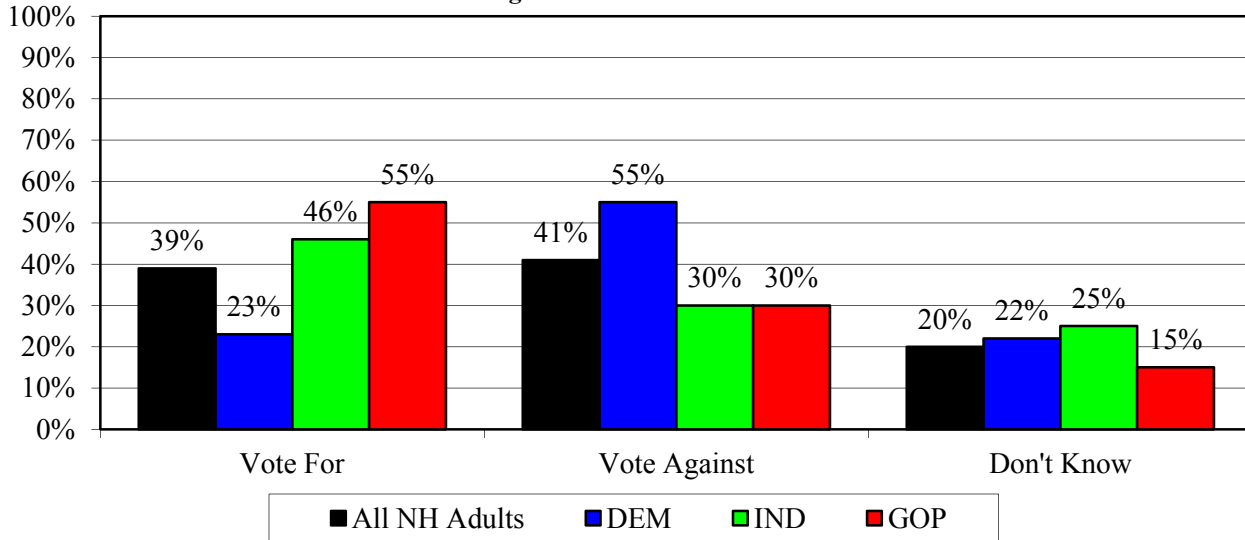
When asked if they support or oppose Northern Pass, attitudes are mixed. Currently, 42% of New Hampshire adults who are familiar with Northern Pass support the project (16% strongly support and 26% somewhat support), 37% oppose the project (23% strongly oppose and 14% somewhat oppose), and 21% are neutral or don't know enough to say. There has been a slight increase in support for Northern Pass since last spring.

Recently, an amendment to the New Hampshire Constitution has been proposed that would prohibit the implementation of a state income tax. When asked whether or not they would vote for this amendment if it were on the ballot, Granite Staters were evenly divided. In the most recent Granite State Poll, 39% said they would vote for the amendment, 41% would vote against it, and 20% don't know. However, it would require a two-thirds majority for this amendment to pass. The proposed amendment gets support from a majority of Republicans (55%) and a plurality of Independents (46%), while Democrats (55%) would oppose the amendment.

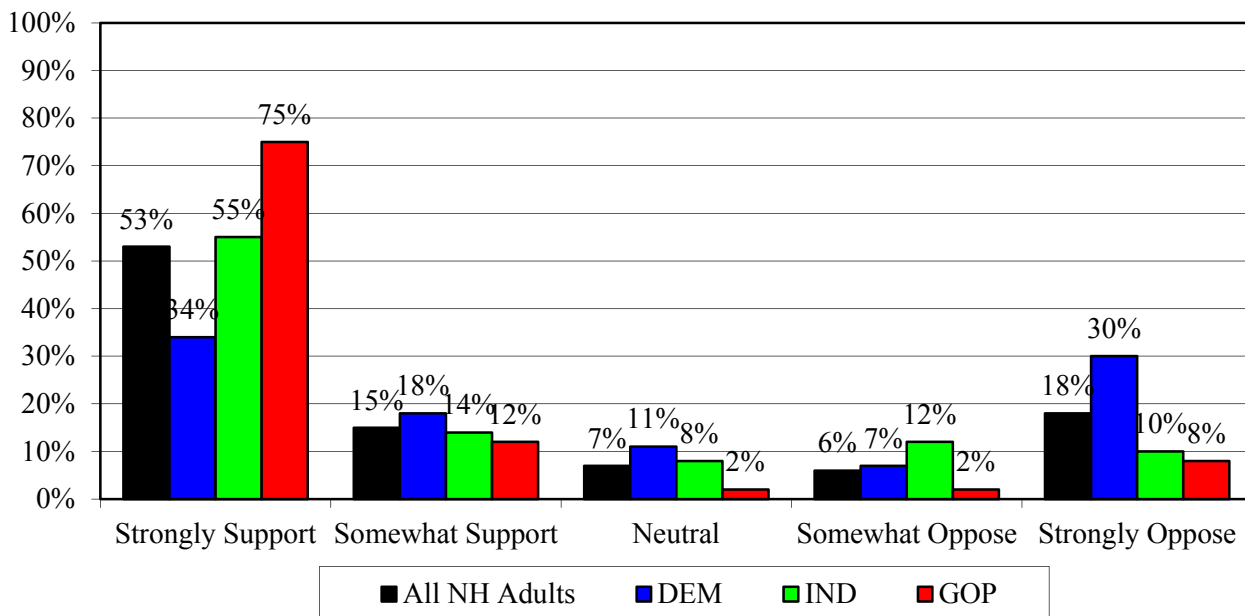
Vote For/Against Income Tax Amendment



Voter ID Law

Yet another issue the NH Legislature will consider is a law which would require voters to show a picture ID in order to vote. There is strong support for such a law. In the most recent Granite State Poll, 68% of New Hampshire adults said they support a voter ID law (53% strongly support and 15% somewhat support), 24% oppose this law (18% strongly oppose and 6% somewhat oppose), and 7% are neutral or don't know enough to say. Support for the law is bipartisan, with majorities of Republicans (87%), Independents (69%), and Democrats (52%) supporting the law.

Granite State Poll Methodology

These findings are based on the latest WMUR Granite State Poll, conducted by the University of New Hampshire Survey Center. Five hundred twenty-seven (527) randomly selected New Hampshire adults were interviewed by landline and cellular telephone between January 25 and February 2, 2012. The margin of sampling error for the survey is +/- 4.3 percent. Included is a subsample of 495 likely general election voters (margin of sampling error +/- 4.4%).

The data have been weighted to adjust for numbers of adults and telephone lines within households, respondent sex, and region of the state. In addition to potential sampling error, all surveys have other potential sources of non-sampling error including question order effects, question wording effects, and non-response.
