RESEARCH INTERESTS

My research focuses on the crime epidemic in Latin America, and its implications for democratic governance. I examine the impact of the crime wave on democratic institutions, citizens' political attitudes and behavior, and migration trends. My work assesses the political consequences of personal experiences with crime, as well as perceptions of crime locally and nationally, in distinct national and sub-national settings. I also study the formation of justice institutions in Latin America, and the ability of these institutions to garner legitimacy in the eyes of average citizens. I also analyze contemporary democratic backsliding and public support for authoritarian leaders.
