## SECTION 1. SUMMARY

The Third National Juvenile Online Victimization Study (NJOV3) was conducted by the Crimes against Children Research Center at the University of New Hampshire and funded by Grant No 2009-SNB-90001, awarded by the Office of Juvenile Justice and Delinquency Prevention, Office of Justice Programs, U.S. Department of Justice.

The NJOV3 Study had three related components.

- The **NJOV3 Arrest Study** used a two-phase process to collect data about technology-facilitated child sexual exploitation crimes ending in arrest in 2009 (e.g., sex offenders using the Internet to meet minors, solicitations to undercover investigators posing online as minors, downloading of child pornography).
- The **NJOV3 Sexting Study** examined the prevalence and characteristics of sexting cases handled by police during 2008 and 2009. It used the same two-phase data collection process of mail surveys followed by telephone interviews. - The **NJOV3 Prosecutor Study** involved interviews with prosecutors about strategies for handling technology-facilitated child sexual exploitation crimes, including sexting.

The NJOV3 Arrest Study is the third wave of a longitudinal study. Wave 1 (NJOV1) pertained to arrests for technology-facilitated crimes that occurred between July 1, 2000 and June 30, 2001; Wave 2 (NJOV2) pertained to arrests during 2006. The final NJOV3 longitudinal data set, weighted to account for sampling procedures and non-response, includes data from 2,962 completed interviews (NJOV1 n=612, NJOV2 n=1,051, NJOV3 n=1,299)

For each wave of the NJOV Arrest Study, data was collected in two phases. Phase 1 was mail survey of a national sample of law enforcement agencies that asked if agencies had made arrests for technology-facilitated child sexual exploitation crimes during a specific time frame. Phase 2 was telephone interviews with investigators to collect details about individual cases reported in the mail surveys. The goal of this methodology was to 1) utilize a representative national sample of law enforcement agencies that would give us an overall picture of these crimes in the United States, 2) understand how these cases emerged and were handled in a diverse group of agencies, 3) get detailed data about the characteristics of these crimes from well-informed, reliable sources, and 4) see how the prevalence and characteristics of such crimes may have changed over time.

## SECTION 2. SAMPLE SELECTION

### *Section 2.1. National mail survey of law enforcement agencies*

The NJOV3 sample of law enforcement agencies was designed to yield a nationally representative sample of technology-facilitated child sexual exploitation cases (i.e., sex offenders using the Internet or other electronic technologies to facilitate sex crimes with juvenile victims, solicitations to undercover investigators posing online as minors, child pornography possession and distribution). We used a three-frame stratified sample of agencies because arrests for such crimes do not occur with equal probability among the more than 15,000 U.S. law enforcement agencies. We divided agencies into three sampling frames based on their specialization, training or known experience with technology-facilitated sex crimes against minors. This was done so that we could get information from the agencies that were most likely to see these types of crimes while still allowing every agency a chance to be selected for the sample. The sample of agencies was recruited and classified into frames for the first NJOV Study, with some changes made in the second and third wave to accommodate alterations in the status of sampled agencies (e.g., some agencies began to specialize in technology-facilitated crimes; some ceased to exist; some were added to the first frame because they were known to have experience investigating certain types of cases).

The NJOV3 first frame sample consisted of 176 agencies. These included 61 Internet Crimes Against Children (ICAC) Task Forces, which are funded by the US Department of Justice to investigate technology-facilitated child sexual exploitation crimes; 38 agencies which were satellite ICAC Task Forces during Wave 1; 16 agencies which were known to work with civilian groups that conducted independent investigations of technology-facilitated crimes

(included for the NJOV2 Study), and 61 agencies that, according to media reports, had handled sexting cases (included for the NJOV3 Sexting Study).

We did not sample first frame agencies; rather, we surveyed all of them. In addition, two federal agencies were included in the study “with certainty.” These were not counted in the mail survey sample because they reported their cases electronically rather than through mail surveys due to large caseloads. Of the 176 first frame agencies that received mail surveys, 3% (n=5) lacked jurisdiction. Of the 171 eligible agencies, 81% (n=138) returned completed surveys and 57% (n=97) reported making one or more arrests for technology-facilitated child exploitation crimes. (See Table 1 for the dispositions, by frame, of the NJOV3 Arrest Study mail survey sample.)

The second frame consisted of agencies that we considered more likely than other agencies to have investigated technology-facilitated child sexual exploitation crimes because they had staff that had received training in these types of cases. We identified these trained agencies prior to NJOV1 by using lists of agencies participating in week-long training programs. The lists were acquired from two training organizations, SEARCH and the National Center for Missing & Exploited Children. Also, an additional agency from a large metropolitan area was included with certainty in the second frame to ensure that agencies from all major metropolitan areas in the U.S. were included in the sample. There were 1,636 agencies in the NJOV3 Study second frame population, with approximately 50% selected to receive the mail survey. (These agencies were selected in Wave 1 (NJOV1) and resurveyed in NJOV2 and NJOV3.)

Of the second frame agencies that received mail surveys in Wave 3 (n=815), 3% (n=28) were ineligible to participate because they lacked jurisdiction to investigate technology-facilitated child sexual exploitation crimes or the agency no longer existed. (In this category were mostly small town agencies that relied on county or other larger jurisdictions to conduct criminal investigations.) Of the 787 eligible second frame agencies, 84% (n=659) completed and returned mail surveys, and 35% (n=275) reported making one or more arrests for technology-facilitated child exploitation crimes.

The third frame consisted of 13,572 other local, county and state law enforcement agencies across the US. The third frame sample was drawn using a database available through the National Directory of Criminal Justice Data (National Directory of Law Enforcement Administrators, 2009). This data set included an annually updated census of local, county, and state law enforcement agencies and was designed to provide geographic and other identifying information for each record included in either the FBI’s Uniform Crime Reports files or the Bureau of Justice Statistic’s Directory of Law Enforcement Agencies. The agencies in the first and second frames were cross-referenced with third frame agencies in the database to avoid duplication among the three frames. Of the 13,572 third frame agencies, 12% (n=1,662) were randomly selected to participate in the study. (These agencies were selected in NJOV1 and resurveyed in NJOV2 and NJOV3.) Of the 1,662 third frame agencies that received mail surveys in Wave 3, 9% (n=157) were ineligible to participate because they lacked jurisdiction to investigate technology-facilitated child sexual exploitation crimes, the agency no longer existed, or the agency was a duplicate

of another agency within the third frame. Of the 1,505 eligible agencies, 88% (n=1,331) completed and returned mail surveys, and 14% (n=218) reported one or more arrests for technology-facilitated child sexual exploitation crimes.

As noted above, the sample of law enforcement agencies was designed for the first NJOV Study, with some changes made in the second and third wave to accommodate alterations in the status of sampled agencies (e.g., some agencies began to specialize in technology-facilitated crimes; some ceased to exist; some were added to the first frame because they were known to have experience investigating certain types of cases). Table 2 provides the details and dispositions of the Wave 1 (NJOV1) and Wave 2 (NJOV2) mail survey samples.

### **Section 2.2. Telephone interviews about specific cases**

We conducted detailed telephone interviews with law enforcement investigators to gather information about arrests for technology-facilitated crimes reported in the mail survey. The 2,128 agencies that responded to the NJOV3 mail survey, plus the two federal agencies that participated reported 4,010 arrests for technology-facilitated child sexual exploitation crimes in 2009, with 97 first frame agencies reporting 2,342 arrests, 275 second frame agencies reporting 1,141 arrests and 218 third frame agencies reporting 527 arrests.

We designed a sampling procedure that took into account the number of cases reported by an agency, so that we would not unduly burden respondents in agencies with many cases. If an agency reported between one and three arrests, we conducted follow-up interviews for every case. Sixty-one percent of the agencies that made arrests in relevant cases in NJOV3 fell within this group, compared to 85% in Wave 1 and 71% in Wave 2. For agencies that reported more than three cases, we conducted interviews for all cases that involved identified victims (victims who were located and contacted during the investigation), and sampled other cases. For agencies with between four and fifteen cases, half of the cases that did not have identified victims were randomly selected for follow-up interviews. In agencies that reported more than fifteen cases, cases with no identified victims were divided into two samples, using random selection, and then half of one sample was randomly selected for follow-up interviews. In some agencies, we could not find out which cases had identified victims before we selected cases for the sample, so we sampled from all cases, using the procedure described above.

Of the 4,010 cases reported in all three frames of NJOV3, 38% (n=1,522) were not selected for the telephone interview sample and 11% (n=459) did not meet eligibility requirements for the study (i.e., arrests in 2009 for

technology-facilitated sexual exploitation crimes with victims age 17 or younger, including unidentified victims such as those pictured in child pornography or victims portrayed by undercover investigators posing online as minors.) There were 2,029 eligible cases in the sample. The overall response rate for telephone interviews was 64%. Table 3 provides a more detailed description of the dispositions of the NJOV3 telephone interview sample.

### SECTION 3. IRB APPROVAL AND PRIVACY

All three waves of the NJOV Study were conducted with the approval of the University of New Hampshire's Institutional Review Board and Privacy Certificates were filed in accordance with regulations mandated for research funded by the U.S. Department of Justice.

We informed respondents of the nature and purpose of the research and that participation was voluntary, they could refuse to answer any question or end the interview at any time, responses would be confidential and used for statistical purposes only, data would be kept secure and no published material would identify any agency, respondent, offender, victim or case.

### SECTION 4. INSTRUMENT DESIGN

#### ***Section 4.1. Phase 1 national mail surveys***

The NJOV3 mail survey was a multi-page booklet, formatted so respondents could follow it easily. It pertained to both the NJOV3 Sexting Study and the NJOV3 Arrest Study. It included a "Frequently Asked Questions" section and a glossary of study terms, along with a toll-free telephone number so that respondents could contact the researchers if they had questions. The format of the survey was consistent with that of the two previous NJOV mail surveys although the wording was changed somewhat to account for new technologies since NJOV1 (e.g., cell phones, flash drives). The mail survey was pre-tested and piloted prior to NJOV1. It was modeled after a survey developed by Westat Corporation for use in the Second National Incidence Study of Missing, Abducted, Runaway, and Thrownaway Children (NISMA2) Law Enforcement Child Abduction Study, which surveyed law enforcement agencies about the incidence and characteristics of stereotypical child abduction cases (Finkelhor, Hammer, & Sedlak, 2002; Sedlak, Finkelhor, Hammer, & Schultz, 2002). A copy of the NJOV3 mail survey is attached to this report as **Appendix 1**.

The mail survey asked two primary questions, worded the same in each wave of the survey except for the dates that described the timeframe. The NJOV3 mail survey asked:

1. Between **January 1, 2009 and December 30, 2009**, did your agency make ANY ARRESTS in cases involving the attempted or completed sexual exploitation of a minor, AND at least one the of the following occurred:
  - a. The offender and the victim first met on the Internet
  - b. The offender committed a sexual offense against the victim on the Internet, regardless of whether or not they first met online
2. Between **January 1, 2009 and December 30, 2009**, did your agency make ANY ARRESTS in cases involving the possession, distribution or production of child pornography, and at least on the of the following occurred:
  - a. Illegal images were found on the hard drive of a computer or on removable media (e.g., CDs, flash drives, memory cards, etc.) or on a cell phone possessed by the offender
  - b. The offender used the Internet to order or sell child pornography
  - c. There was other evidence that illegal images were downloaded from the Internet or distributed by the offender over the Internet

If respondents answered "Yes" to any of these questions, we asked them to list the case number, or other reference, and the name of the key investigating officer or most knowledgeable person for each case they reported. Also, we emphasized that agencies should return surveys, even if they had no cases to report.

#### ***Section 4.2. Phase 2 case-level telephone interviews***

Trained telephone interviewers used a computer-assisted telephone interviewing system to gather details about cases reported in the mail survey. The telephone interview was used for both the NJOV3 Sexting Study and the NJOV3 Arrest Study. It consisted of the following sections, some of which were used in each interview and others depending on the facts of the case. A copy of the telephone interview is attached to this report as **Appendix 2**.

- **Preliminary Information.** We used the Preliminary Information section in every interview. It asked for a brief narrative description of the case, screened for eligibility, gathered demographic information about offenders, victims, and asked about the law enforcement agencies involved in the case.
  - To screen for eligibility, the interview asked about whether and when an arrest was made by the respondent's agency and whether the case was technology-facilitated, there was an identified victim who was younger than 18, or the case involved the possession of child pornography or a proactive investigation of online activity.
  - A case was technology-facilitated if the victim met the suspect online or through a cell phone, or the suspect used the Internet or a cell phone or computer or other electronic technology to commit the crime.
  - If a case involved more than one offender, this section identified a primary offender. Later questions about the characteristics of the crime and offender referred to the primary offender. Primary offenders were chosen based on the following hierarchy. First, the offender who directly used the Internet or related technology. If more than one offender used such technology, then the one who committed the most serious crime. If the crimes were equally serious, then the offender who was the youngest.
  - If a case involved more than one victim of a technology-facilitated crime, this section identified a primary victim. Later questions about the characteristics of the crime and victim referred to the primary victim. Primary victims were chosen based on the following hierarchy. First, the victim who directly used the Internet or related technologies. If more than one victim directly used the Internet, then the victim who was most seriously victimized. If the victimizations were equally serious, then the victim who was the youngest.
  - The Preliminary Section also gathered information about the gender and age of any identified victim of a sex crime that was not technology-facilitated who was identified in the investigation. However, we gathered detailed victim information only for victims of technology-facilitated crimes.
- **Sexual Exploitation.** We used the Sexual Exploitation section in cases with identified victims (i.e., victims that were identified and located). In cases where the victim first met the offender on the Internet or via cell phone, this section collected specific information about where online the victim and offender met, how they communicated both on- and offline, whether they met in person, the details of any sexual assault, and other information. In cases with identified victims where the offender and victim did not meet on the Internet, but knew each other in some other capacity (i.e., family and prior acquaintance cases), this section collected specific information about the offender-victim relationship, including how they knew each other, how the technology was used, the details of any sexual assault, and other information about what transpired between the offender and victim during the course of the crime.
- **Production of Child Pornography.** We used this section in cases where there was an identified victim of a technology-facilitated crime who was also a victim of child pornography production or was photographed by an offender in a sexually suggestive pose. This section collected information about the format, number, content and distribution of the produced images.
- **Possession of Child Pornography.** This section was used if the offender possessed child pornography. It collected information about the format, number, content and distribution of the possessed child pornography.
- **Undercover Investigation.** We used the Undercover Investigation section in cases that involved online undercover operations in which law enforcement investigators 1) posed online as minors or adults with access to minors, 2) took over the identities of identified victims, 3) posed as distributors or consumers of child pornography or 4) conducted some other type of proactive investigation of online child sexual exploitation. In all cases, we gathered information so that we could categorize the type of undercover investigation. We gathered detailed information only about cases in which law enforcement posed online as minors. This section included questions about the extent and nature of the online interactions between the offender and undercover investigator and information about face-to-face meetings between offenders and investigators, when applicable.
- **Offender.** The Offender section collected information about the demographic, family, emotional, and behavioral characteristics of the offender in each case. For cases with multiple offenders, information was collected about the primary offender only. This section also captured information about arrests, charges, and outcomes of criminal cases.
- **Victim.** We used the Victim section if the case involved an identified victim of a technology-facilitated crime. It

collected information about the demographic, family, emotional, and behavioral characteristics of the victim. For cases with multiple victims, information was collected about the primary victim only.

• **Interview Conclusion.** The Interview Conclusion was used in all cases and served to finalize the interview, collect information about respondents' training, and capture any other important information about the case that was not covered in the survey.

## SECTION 5: CRITERIA FOR ELIGIBILITY

To be included in the N-JOV3 Arrest Study, cases had to be technology-facilitated, involve victims younger than 18 and end in arrests that occurred between January 1 and December 31, 2009.

1. Technology-facilitated. A case was Internet-related if: 1) an offender-victim relationship was initiated online or via cell phone; 2) an offender who was a family member, acquaintance, or stranger to a victim used the Internet or related technologies to communicate with a victim to further a sexual victimization, or otherwise exploit the victim; 3) a case involved an Internet-related undercover investigation; 4) child pornography was received or distributed online, or arrangements for receiving or distributing were made online; or 5) child pornography was found on a computer, on removable media (flash drives, CDs, etc.), as computer print-outs, or in some other digital format. Internet-related technology included computers, cell phones that were used for texting or taking and sending photographs, and other digital devices (e.g., web cams, gaming devices) used to facilitate child sexual exploitation crimes. We chose broad criteria so we would not exclude any cases that could be technology-facilitated.
2. Victims younger than 18. We chose this definition of minors because 18 is the age of majority for most purposes in most jurisdictions. We did not want to rely on state or federal statutes that define "age of consent," because these statutes vary considerably. However, eighteen is the upper age limit for any statutes defining age of consent. Also, federal and many state statutes define child pornography as images of minors younger than 18. We considered cases to have victims under 18 in three situations: 1) there was an "identified victim," defined as a victim who was identified and contacted by the police in the course of the investigation, who was under 18; 2) a law enforcement investigator impersonated a youth under 18, so that the offender believed s/he was interacting with a minor; and 3) a case involved child pornography, which by definition depicts the sexual abuse or exploitation of a minor under 18.
3. End in arrest. We limited the study to cases ending in arrests, rather than crime reports or open investigations because cases ending in arrests: 1) were more likely to involve actual crimes; 2) had more complete information about the crimes, offenders and victims; 3) gave us a clear standard for counting cases; and 4) helped us avoid interviewing multiple agencies about the same case.

## SECTION 6. DATA COLLECTION

### *Section 6.1. Procedures for the phase 1 mail survey of law enforcement agencies*

To maximize response rates to the Phase 1 mail survey, we followed an adapted version of the "total design" mail survey methodology (Dillman, 2007). These procedures were used in all three waves of the NJOV Arrest Study.

1. We sent surveys, personalized cover letters, and business reply envelopes to the heads of the local, county, and state law enforcement agencies in the sample.
2. Approximately three weeks after the initial mailing, we sent reminder postcards to all agency heads, asking them to complete and return the survey if they had not done so, and thanking them if they had.
3. Approximately six weeks after the initial mailing, we sent additional copies of the survey, personalized cover letters, and business reply envelopes to the heads of agencies who had not responded to date.
4. Approximately nine weeks after the initial mailing, we sent third copies of the survey, personalized cover letters, and business reply envelopes to agency heads that had still not responded.
5. Finally, telephone interviewers called the agencies that had not responded and, when possible, filled out the survey instrument over the telephone.



The mail survey began in January 2010. Mailings concluded in April 2010; calls to non-responders continued while telephone interviews were being conducted - until March 2011. The overall response rate for the mail survey was 86% of eligible agencies.

### ***Section 6.2. Procedures for the phase 2 telephone interviews about specific cases***

Seven trained interviewers conducted the NJOV3 Arrest Study telephone interviews, using a computer-assisted telephone interviewing system, WINCATI. The interview was programmed to include: 1) question and response series; 2) skip patterns; 3) interviewer probes and instructions; 4) range checks; and 5) special edit procedures. The WINCATI system provides a number of benefits over traditional telephone interviewing, including a smoother flowing interview, the ability to branch to different series of questions depending on answers to previous questions, and automated skip patterns. In addition, the use of WINCATI can help to minimize recording errors because the acceptable range of responses is programmed into the data entry program. Since the interviewer actually records each response to survey questions through the data entry program, the risk of data processing errors is reduced.

The interviewers attended a two-day training session led by the researchers that provided extensive details about the background, purpose, and instrumentation of the study, and they participated in a series of observational and practice interviews. The telephone interviews for the NJOV3 Arrest Study were conducted between March 2010 and March 2011.

## **SECTION 7. DATA CLEANING AND CODING**

### ***Section 7.1. Qualitative data***

Upon completion of each interview, interviewers wrote narrative descriptions which summarized each case. Summaries were written into Adobe-created forms and used by the lead investigators to clarify complex cases and to supplement quantitative data findings with qualitative examples of incidents and behaviors.

### ***Section 7.2. Quantitative data.***

Data were transferred directly from the WINCATI system to a SPSS data set. A data manager cleaned the data and supervised the coding of open-ended responses or those that did not fit given categories (e.g. "Other, specify"). Research assistants monitored by the data manager double coded open-ended responses, compared coded responses for discrepancies, and reviewed and resolved discrepancies with one of the lead investigators. After initial cleaning and coding, the data was transferred into Stata Statistical Software, Release 11.1 for weighting and analysis.

## **SECTION 8. WEIGHTING AND VARIANCE ESTIMATES**

### ***Section 8.1. Sample Design and Probabilities of Selection***

The NJOV Arrest Study sample was designed and the weights were calculated by statisticians at Westat, under subcontract to researchers at CCRC.

The NJOV3 Arrest Study data were collected from a stratified two-stage probability sample of agencies and cases within agencies. Agencies were stratified by frame (frame=1, 2, 3), as described above, and a sample of agencies was drawn with equal probability within stratum but variable probabilities across strata. N-JOV3 Arrest Study cases were selected with equal probability within agencies but variable probabilities across agencies.

The overall probability of selection for any given case was equal to the product of the agency and case probability of selection, which were each adjusted individually for multiple chances of selection. The relevant calculations for the agency and case probabilities of selection were as follows:

Agency Sample

The probability of selection for a given agency (j) was calculated as the ratio of the sample size for the stratum to

the population size for the stratum,  $p_{1,j} = \frac{n_h}{N_h}$ . The agency probability of selection was adjusted for duplication

in the agency sampling frame as  $p_{1,i} = 1 - \prod (1 - p_{1,j})$ , where  $p_{1,j}$  is the probability when agency (j) was selected in a single frame;  $p_{1,i}$  is denoted as the overall probability for agency (j) when counting the selection in all frames.

Case Sample

The probability of selection for a given case (j) within an agency was calculated as the ratio of the case sample size

for the agency to the total case size for the agency,  $p_{2,j} = \frac{n_h}{N_h}$ . Some agencies further divided cases into groups

and sampled from them. In that case the sample size and the total size were counted within group. If all the cases were selected from an agency or a group, those cases were called selected with certainty having probability of selection of 1. Similarly to the duplication of agencies in the sample, where separate cases j on the frame actually

represented the same case i, their probability of selection was adjusted by  $p_{2,i} = 1 - \prod (1 - p_{2,j})$ .

Agency Weights

Given the unequal probabilities of selection for agencies, weights were required to ensure unbiased estimation (Kish, 1992). Base weights were calculated for each agency as the reciprocal of the unduplicated agency probability

of selection,  $w_{1,i} = \frac{1}{p_{1,i}}$ .

Case Weights

All Sexting Study cases were included in the sample, as a result YPI case weights equal to 1, i.e.  $w_{2,i}=1$ .

Agency Nonresponse Weight adjustment

The weights of nonresponding agencies were redistributed to the responding agencies, using the cell weighting method (Sarndal, Swensson and Wretman, 1992).

The sampled agencies were initially partitioned into eleven groups differentiated by agency size within stratum, which resulted in 35 original nonresponse adjustment cells (33 cells plus two stand-alone strata for two federal agencies that participated). The final number of agency nonresponse adjustment cells was 22, as small cells were collapsed in order to control the variability in nonresponse adjustment factors. Table 3 summarizes the cell definitions. In each defined cell, the agency base weights were adjusted by the ratio of sums of weights for all eligible units to the sums of weights for all responding units.

### Case Weight Adjustment

Two adjustment steps were conducted for the NJOV3 Arrest Study case base weights: nonresponse adjustment and poststratification. The case base weights were first adjusted for nonresponse by the ratio of sums of weights for all eligible cases to the sums of weights for all responding cases in each cell. Nonresponse adjustment cells were defined by sampling stratum. Poststratification was then used to essentially add 880 JOV arrests made by U.S. Immigration & Customs Enforcement (ICE) during calendar year 2009, to the estimate of the case total in stratum 1 (type=1).

### **Section 8.2. Estimation and Variance Estimation**

The NJOV3 weights and variance estimation variables were designed to support analysis in STATA which allows the user to specify multi stage sample design information, and account for the variation from both agency selection and case selection stages. Six variables were constructed to specify the two-stage sample design, per STATA's requirements:

- STRATA: This variable was created to reflect the sampling frame from which the agency or case was selected.
- PSU: It identifies the primary sampling unit, agency, to account for the clustering of agencies.
- FPC1: This variable reflects the overall sampling rates of agencies within stratum, to account for the sample being selected without replacement.
- SSU: It identifies the second sampling unit, case, to account for the clustering of cases.
- FPC2: This variable reflects the overall sampling rates of cases within an agency, to account for the sample being selected without replacement.
- PWEIGHT: The final case weights.

The results will be reported to the U.S. Department of Justice and be available to law enforcement agencies.

**Why is the N-JOV Study being conducted?** The N-JOV Study measures growth and change in technology-related sex crimes against juveniles. We have conducted two previous surveys. The 1<sup>st</sup> asked about cases ending in arrest in 2000 and the 2<sup>nd</sup> asked about arrest cases in 2006. Policy makers and law enforcement officials will use the final study results to help secure resources for investigators and encourage citizens to report these crimes. **The enclosed bulletin is an example of the information this research provides to law enforcement policy makers.**

**Who sponsors the N-JOV Study?** The N-JOV Study is sponsored by the U.S. Department of Justice, Office of Juvenile Justice and Delinquency Prevention.

**Who is conducting the N-JOV Study?** Researchers at the Crimes against Children Research Center (CCRC) at the University of New Hampshire are conducting the N-JOV Study. The CCRC has completed numerous studies about crimes with juvenile victims.
