III. Discussion

<u>Concern regarding "pathways" courses approved for majors not matching coded Discovery designations:</u> The DC discussed the confusion regarding transfer courses approved for one Discovery designation being used as equivalent to courses in major that meet a different Discovery designation. Nicky will follow up on this issue.

Status of Discovery Review Committee (DRC) Proposal: Nicky informed the DC that the Faculty Senate has voted to create a new ad hoc committee for review of the Discovery Program. The senate will also appoint a separate committee on the addition of a diversity requirement in Discovery. Some DC members expressed concern at the "starting over" of this process, noting that whatever comes through in a new proposal will likely be very similar to the changes and enhancements in the current DRC proposal. They also expressed concern about the effect this decision will have on

students and recent alumni who put considerable time and energy into the review process and advocated for changes, particularly increased flexibility in Discovery (e.g., using upper-level courses to meet Discovery requirements) and the addition of the diversity and sustainability requirements included in the DRC proposal. Nicky will keep the DC posted on any developments.
