# III. <u>Discussion</u>

HUMA 526: Humanities & Science course title - The DC discussed concerns around the title of the recently approved new offering under special topics course, HUMA 526. The DC acknowledged that while the new course looks to be excellent, there was a certain sensitivity regarding use of the word "science" and that perhaps "pseudo-science" would be more accurate here. The DC also acknowledged that is it not their mandate to micromanage Discovery courses and that a suggestion to the faculty person about the title of their course, was a friendly suggestion to be considered and not a stipulation to the course being approved – the course has been approved. The DC agreed that Nicky would write to the faculty person and suggest an edit to the title of the course.

Teaching in the Discovery categories – The DC discussed concerns around faculty offering courses outside of their discipline, or area of expertise. Discussion included whether the option to collaborate across disciplines on courses was supported (other than when an Honors Symposium course). It was pointed out that the Discovery categories were to be about the disciplines, not as much about the subject matter and that the place where that was to happen was in the INQ

courses, which it no longer does. Discussion also included concerns around the financial impact of Discovery on departments and colleges, and how that cannot be ignored during Discovery Program review.

Huron Consulting Group – The Huron Consulting Group is interviewing people on campus regarding budgeting and resources. Nicky will try to meet with them.
