#### Minutes

## The Committee discussed the following:

Update on BIOL 412 (Evolution, Biodiversity, and Ecology)

o In April 2013 the Discovery Committee voted to keep BIOL 412 in pilot status for an additional two years. BIOL 412 is structured as a large lecture course with small labs. The small labs are designed to meet INQ measures. The CETL assessment report from August 2015 indicated that BIOL 412 is now meeting the benchmark standard of 4.00 on the five Inquiry rating questions

Motion: Barb White moved and Rosemary Caron seconded to remove pilot Inquiry status for BIOL 412 with two stipulations. Stipulations on full Inquiry (INQ) approval require that: a) the TA training conducted by CETL continue, or that BIOL submit evidence of TA training to the Discovery Committee; and b) the INQ assessment continues in the form of the 5 additional questions asked of students in the Teaching Evaluation Form at the end of the semester. Please note that this assessment task is required of all INQ courses. Vote: 6 yes; 0 no; 0 abs. Motion passed.

#### **Student Petitions**

- 1. Petition to allow ANTH 680 to fulfill WC requirement. Historically, if a UNH course is not a Discovery course the committee will not allow it to fulfill a Discovery category. **Vote:** 0 yes: 6 no; 1 abs. **Petition denied.** (rcchhsdate)
- 2. Petition to allow Art History course taken in Dijon France to fulfill FPA requirement.

Motion: Table decision until we obtain more information from advisor.

Vote: 6 yes; 0 no; 0 abs. Petition tabled. (tbcepscola09012015)

3. Petition to allow PSYCH 705 (Manchester) to count as capstone credit. Capstones are usually completed after having 90 credits. This student currently has 89 credits and is one credit short of the 90 credits needed to take a capstone.

Vote: 6 yes; 0 abs; 0 no. Petition approved. (mbunhm091115)
