Dialogue: The discussion centers on confusion and frustration over a writing-intensive course whose description language was altered despite

already carrying a WI designation, raising concerns about why the changes were made and whether the course still meets WI requirements. There is an acknowledgment that while all WI courses were reviewed for compliance at the time of an institutional merger, courses can be modified from semester to semester without centralized oversight, leading to inconsistency. Review of designated WI courses often relies on quick syllabus checks and informal approval, even when criteria may no longer be fully met. The group notes broader structural problems, including inconsistent guidelines across offices and the difficulty of fairly judging compliance in such a fragmented system. Separately, it is emphasized that peer-review and peer-engagement practices can function effectively even with staggered timelines, but only if instructors receive proper training and guidance on how to implement these methods well. In the discussion, the committee discussed Artificial Intelligence (AI) and its use in Writing Intensive courses. The committee members support AI and are in favor of embracing Artificial Intelligence.
